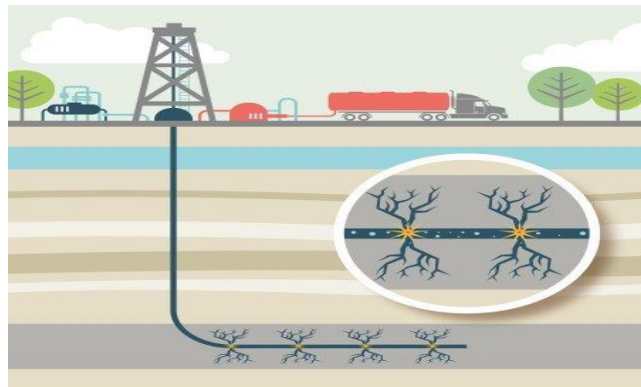

## Fracking and tour of Brockholes Nature Reserve – 4<sup>th</sup> May 2017
