Meadow Foods has developed from a small dairy trading firm in 1992 to now being one of the UK's largest independent supplier of milk and dairy ingredients to the food industry. The company operates from 3 sites supplying over 100,000 tonnes of bulk dairy products to food manufacturing, wholesale and food service industries with milk supplied directly by 650 farmers. The site at Chester is the home of Meadow Foods and is at the centre of the Meadow Foods Fat Business which produces butter, butter oil and milk concentrates. The Chester site covers 11 acres and has seen substantial investment in state of the art processing. It should be an eye opening and highly informative visit
