Agricultural Law Association Starter for Ten 13 to 15 March 2018 Radcliffe Conference Centre, University of Warwick

Cost: £975 (no VAT) including all course materials and overnight accommodation on 13 & 14 March

The Association invites applications to attend the Starter for Ten course. Whilst it is primarily intended for trainees and the recently-qualified, newcomers to the field may find it useful in gaining a sound understanding of this important area of law and practice.

The syllabus is outlined below but, as well as agricultural tenancies, it will include a detailed examination of unregistered conveyancing and the Common Agricultural Policy, with the related trust, tax and litigation issues running alongside.

The course is run over three full days, packed with teaching and tutoring both formal and informal, structured and free-form, with ample opportunity for subjects to be explored in discussion and questions to be answered. No knowledge is assumed, and no question is considered too basic.

The course will provide 15 hours CPD requirement in solicitors, surveyors and accountants.
