

SPEAKER BIOGRAPHIES

Peter Kellett

Peter has a science degree and a masters in environmental law. He trained as a solicitor and worked in the City and Brussels. He joined the Environment Agency in 1997. Peter's work has included:

- the Defra / Welsh Government / Environment Agency team creating the Environmental Permitting (England and Wales) Regulations
- civil sanctions implementation
- better regulation
- the creation of Natural Resources Wales
- EU Exit

His team's work includes: permitting, compliance, enforcement and sanctions across a wide range of environmental laws; carbon regulation; the six-year flood capital programme; fracking; navigation; invasive species; nuclear new build; and fish regulation.

Peter was a trustee and then chair of the UK Environmental Law Association (www.ukela.org) between 2001 and February 2011. Peter then became a trustee and later chair of St Werburghs City Farm in Bristol until September 2018. He has written regularly about developments in environmental law, for example, *Successes of Environmental Law Over the Past 30 Years, the Challenges that Lie Ahead and the Solutions that Environmental Law can Provide* (2018) JPL 1090-1102, 1 September 2018.

Alison Pryor

Called in 2008, Alison is valued for her tenacious demeanour and has been praised for her thorough and forensic advocacy.

Her practice encompasses the full range of environmental law.

Alison is the head of chambers' environmental law team and has in-depth knowledge of the regulatory landscape in this area and an understanding of the technical issues that commonly arise. It is her background in general criminal law, however, that has proven to be a valuable resource in cases where what is required is realistic and sensible advice on how to defend a prosecution in the criminal courts.

She is regularly instructed in prosecutions brought by the Environment Agency in respect of sewage pollution incidents and has significant experience in advising on and presenting evidence to challenge the prosecution case on culpability and harm. In addition, she frequently appears in cases where the correct application of the sentencing guidelines to "very large organisations" (i.e. where annual turnover is in excess of £250m) is in issue and was instructed as junior counsel in what is currently the largest prosecution ever brought by the EA against a water company, at Aylesbury Crown Court in February – March 2017. She also appeared in the Court of Appeal as junior counsel for the defendant water company in the first appeal brought under the new sentencing guidelines for environmental offences (*R v Thames Water Utilities Ltd* [2015] EWCA Crim 960, [2015] 2 Cr App Rep (S) 439, [2015] 1 WLR 4411, [2015] Crim LR 739, 165 NLJ 7657, (2015) Times 21 August).
