We trust that this event will appeal and be of use to all those who undertake conveyancing of rural dwellings, sites and land as well as fulfilling the Law Society's compulsory 3 hour conveyancing CPD requirement.

Peter Brown is the Northern Ireland Regional organiser of the Agricultural Law Association, the Northern Ireland representative on the ALA Council and its Brexit Sub Committee and a solicitor with Martin King French & Ingram. He has been a member of the DARD/DAERA Independent Review Panel since 2012 and along with Brian Walker and Andrew Kirkpatrick of the Law Society drafted the new Law Society of Northern Ireland Agricultural Property Replies to Pre Contract Enquiries which were launched in 2018.

Brian Walker became a solicitor in 1975, a partner in Watson & Neill in 1977 and founded Walker McDonald with Joseph McDonald in 1984. Brian's interests in agriculture have led to many cases of litigation on behalf of farmers and his appointment as national advisor to the National Beef Association. As well as drafting the new Law Society of Northern Ireland Agricultural Property Replies to Pre Contract Enquiries Brian is a member of the Law Society Council and Conveyancing Sub Committee and has delivered previous LSNI CPD on rural conveyancing.

Stephanie Millar is the Head of Water Regulation at The Northern Ireland Environment Agency an Executive Agency within the Department of Agriculture, Environment and Rural Affairs with responsibility under the Water (Northern Ireland) Order 1999 for regulating consents to the discharge of trade or sewage waste to any waterway, or any water contained underground including waste from any commercial, industrial or domestic premises not connected to the public sewer. The talk will address the current regulatory regime and proposed future changes which may be of interest to conveyancers.

These talks will be followed by a Panel Question and Answer which will include the speakers and other experts on these and other current rural conveyancing topics.
