**Farms, Promises and Half Truths**

*Leslie Blohm QC and Christopher Jones, Barristers, St John's Chambers*

Leslie and Christopher will deliver a lecture on informal agreements and partnership assets in a farming context. The talk will look at the recent cases of *Wild v Wild* [2018] EWHC 2197 and *Ham v Bell* [2016] EWHC 1791 and consider what lessons can be drawn from those judgments and applied by the busy practitioner.

Following Leslie and Christopher's lecture, delegates will be given a case study containing a scenario and series of questions for discussion and debate!

**Partnership Disputes – An Accountant's Approach**
