Mark Catley FRICS FAAV, Consultant, Cheffins

Mark Catley is a Fellow of the Royal Institution of Chartered Surveyors having qualified in the General Practice Division in 1981. He is an RICS Registered Valuer and also a Fellow of the Central Association of Agricultural Valuers (CAAV). He has been practising as a chartered surveyor for over 37 years in both the commercial and rural branches of the profession.

He was District Valuer East of England and Group Valuation Officer before he joined Cheffins in 2011 mainly to spearhead commercial, taxation and agricultural advice to clients and to assist the legal profession in expert witness work. He has experience of valuing commercial and residential property all over the East of England and large agricultural estates for Inheritance Tax, Capital Gains Tax and for compulsory purchase purposes. He is considered an expert in Business Rates valuations and disputes. In terms of asset management he has valued the Cambridge University and College Estates and the NHS Estate throughout East Anglia.

He is a seasoned advocate and expert witness in property litigation and has appeared in over a thousand cases before the Courts (UK Upper Tribunal (Lands Chamber), High Court, Valuation Tribunals, County Court) in matrimonial disputes, general practice matters, agricultural valuations and taxation disagreements. He is presently involved in the resolution of dilapidations disputes, both in the mediation sphere and the Courts and has dealt with a number of overage and restrictive covenant cases.

Mark has been a chairman of the RICS in Cambridge, a practical examiner for the CAAV for many years and was recently chairman of its Written Examinations Board. He is currently a member of the national CAAV General Council. He has been Chairman of the Cambridge and Isle of Ely and Wisbech Agricultural Valuers' Associations. In his spare time he is a working trustee for an international charity in respect of property-related matters.
