Mark Borland obtained his degree in law at Dundee University, graduating in 1994 then trained with Conway, Flood & Todd (as the firm then was) qualifying in 1996 and becoming a partner in 2001. He specialises in conveyancing, wills and probate, licensing and commercial law and is a member of the Law Society Council as a Constituency Representative for the Northern Circuit. He is also a founder member of the Law Society’s Elder Law Group and the author of an article in the recent first issue of the Law Society’s “Journal of Elder Law and Capacity” entitled “Family Homes and the cost of care – some observations on advising clients”. Mark will be talking about the ever pertinent issue of funding residential care with particular reference to the agricultural community.

Mike Holland has been the Consultant Secretary and Adviser to ALA since June 2016. He graduated in Land Management from the Royal Agricultural University in 1999 and was a surveyor and Director of King West independent Chartered Surveyors, Land Agents, Estate Agents, Commercial Agents, Town Planners and Development Consultants operating in the East Midlands from 1999-2016 before leaving to take up his current post with ALA. He will be talking about the current statutory tenancy schemes in England Wales and Scotland, current proposals for their reform and the implications for professional advisers of any possible future extension of a similar scheme to Northern Ireland.

These talks will be followed by a Panel Question and Answer which will include the speakers and other experts on these and other current rural topics.
