#### ENVIRONMENTAL LAND MANAGEMENT SCHEME

#### **ENGLAND TREE STRATEGY**

DEFRA has published a consultation on a new England Tree Strategy which plans to accelerate tree planting and improve the management of existing trees and woodlands.

#### 3. TRADE & AGRICULTURE COMMISSION

As widely reported in the farming press, Secretary of State for International Trade, Liz Truss, has announced an 'in principle' agreement to establish a Trade & Agriculture Commission under the Department for International Trade.

The recommendations of the Commission would be advisory only and the Commission's report should focus on:

- a) Considering the policies that the Government should adopt in free trade agreements to ensure UK farmers do not face unfair competition and that their high animal welfare and production standards are not undermined;
- b) Reflecting consumer interests and those of developing countries;
- c) Considering how the UK engages the WTO to build a coalition that helps advance higher animal welfare standards across the world;
- d) Developing trade policy that identifies and opens up
- 4. SCOTTISH GOVERNMENT GUIDANCE FOR FARMERS, CROFTERS AND OTHER AGRICULTURAL WORKERS ON MEASURES TO PREVENT SPREAD OF COVID-19.

#### 6. BUSINESS AND PLANNING BILL

A Bill to make provision relating to the promotion of economic recovery and growth includes extending planning permission and listed building consent deadlines in England.

Permissions and consents that are due to lapse between 23 March and 31 December 2020 are to be extended until 1 April 2021.

Planning permissions which have already lapsed before these provisions come into force, will be subject to an additional Environmental Approval process before the automatic extension can take effect.

The Bill had its a second reading in the House of Lords yesterday and is anticipated to receive Royal Assent before the summer recess.
